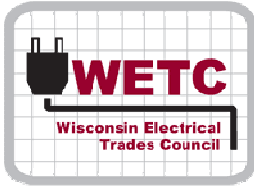

## Membership Opportunities

### **Contractor Membership - Annual Dues \$100.00**

- ◆ Must hold a current Wisconsin Building Contractor Registration or Electrical Contractors Certification.
- ◆ Must be, or must employ, a Master Electrician as certified by the State of Wisconsin.
- ◆ Must provide a Federal ID # or Social Security #
- ◆ Must maintain a minimum of \$100,000 Contractor Liability Insurance and provide a current Certificate of Insurance.
- ◆ Is eligible for all benefits and membership discounts offered by WETC.
- ◆ May register up to two (2) employees for WETC sponsored events or classes.

### **Electrician/Inspector Membership - Annual Dues \$100.00**

- ◆ Must hold a current Wisconsin Certification as a Master, Journeyman or Beginning Electrician, or a residential/commercial Electrical Inspectors Certification.
- ◆ Does not require employment by a current Contractor Member.
- ◆ Does not need to supply business information or certificate of insurance.
- ◆ Is eligible for all benefits and membership discounts offered by the WETC.
- ◆ Cannot register employees for WETC sponsored events or classes.

### **Associate Membership - Annual Dues \$150.00**

- ◆ Includes Businesses such as utility companies, wholesalers, suppliers, vendors or equipment suppliers who offer services or support to the electrical trade.
- ◆ Does not need to supply business information or certificate of insurance.
- ◆ Is eligible for all benefits and membership discounts offered by the WETC.
- ◆ May register up to two (2) employees for WETC sponsored events or classes.
- ◆ Receives recognition at all WETC sponsored events and in any publications of the WETC.
- ◆ Agrees to place, distribute or make available to customers or clients any information about WETC sponsored events or classes.

### **Retired Membership - Annual Dues \$20.00**

- ◆ Includes Contractors, Electricians, Inspectors or Associate Members of the WETC who have retired and wish to stay active in current State of Wisconsin electrical affairs and Wisconsin Electrical Trade Council business and sponsored events or classes.
- ◆ Must provide a letter stating date of retirement and verification of retirement status upon request of the WETC office.
- ◆ Is eligible for all benefits and membership discounts offered by the WETC.
- ◆ Cannot register employees for WETC sponsored events or classes.
